7.1 Sales:

- a. After a slow start, sales picked up later in the month to eventually exceed budget by R3 018. Two successful private functions contributed favourably to this excess.
- b. A surplus of R 22 056 was realised by these sales, which was an improvement against budget, by R1 816.

7.2 Other Income:

Unbudgeted payments from Messrs Duncan and de Jager, for the hire of the Club's facilities for their private functions, together with the sale of t-shirts and some surplus Club stock (scuttles), resulted in this favourable variance of R2 885.

7.3 Expenditure:

Total expenditure for the month amounted to R50 676. This was lower than budget by R1 379, mainly as a result of reduced repairs and maintenance requirements. This was however, partially offset by higher overtime and the purchase of Club t-shirts for stock.

7.4 Net Surplus / Deficit

A net surplus of R9 664 was realised in the month, which exceeded the budget of R3 584 by R6 080. A good month all round with bar sales up and costs down.

8.1 Correspondence.
